

# **FUEL DRIVE-OFF**

# **REPORTING PACK GUIDE**

A Fuel Drive-off occurs when a person puts fuel into a vehicle and drives off without paying. It may be considered a Stealing Offence.

The steps below detail the process for a Service Station to report a Fuel Drive-off incident to the Western Australia Police Force.

1. Service Station employee to immediately report the incident to the Western Australia Police Force on telephone 131 444. The Service Station employee may be advised to complete a Fuel Drive-off Reporting Pack for submission to the local police station.

If completion of a Fuel Drive-off Reporting Pack is advised:

- 2. Service Station employee to print a transaction receipt of the Fuel Drive-off incident. Transaction receipt to include the incident date and time, fuel type and amount in litres, and value of fuel in dollars and cents.
- 3. The Service Station employee who witnessed the incident to complete Form 1 Eye Witness Particulars and a statement. The statement is to be signed by the Service Station employee and witnessed by a police officer.
- 4. Download Closed Circuit Television (CCTV) footage related to the incident onto a portable device, such as a USB Drive, CD or DVD. The footage will be used as evidence.
- 5. The Service Station employee who downloaded the CCTV footage to complete Form 2 - Other Significant Witness Particulars and a statement. The statement is to be signed by the Service Station employee and witnessed by a police officer.
- 6. The owner/manager/business representative of the Service Station to complete Form 3 - Other Significant Witness Particulars and a statement. The statement is to be signed by the owner/manager/business representative of the Service Station and witnessed by a police officer.
- 7. Use the Fuel Drive-off Reporting Pack Checklist (page 2 of this document) to ensure all required documents are completed and signed.
- 8. Deliver completed Fuel Drive-off Reporting Pack to the local police station.
- 9. Police will review the submitted Fuel Drive-off Reporting Pack. If an Incident Report is generated, police will provide the report number to the Service Station.
