A valid application will be processed as soon as possible (and, in any case, within 45 days after it is received or an extended timeframe agreed upon with the applicant).

## **Forms of Access**

You may request access to documents in many ways including by inspection or requesting a copy of a document. Other methods of access are available.

Where WA Police Force are unable to grant access in the form requested, access may be given in another form.

**Fees and Charges** 

PERSONAL INFORMATION: No fees or charges are applicable for access applications requesting

(only) the personal information of the applicant.

NON-PERSONAL INFORMATION: \$30.00 application fee required at the time of lodgement. Payment of

application fees can be in the form of cheque or money order made payable to the Commissioner of Police. If lodging in person, EFTPOS or cash payment options are also available. This fee cannot be waived,

and is required to make a valid application.

Additional charges may apply for dealing with the application, postage, reproduction of documents or specialised access arrangements. Additional charges may be waived if the applicant is impecunious and

able to provide evidence to substantiate this claim.

No fees are applicable for an internal or external review.

## **Identification / Authority**

Proof of ID is required before any documentation is released. This can be in the form of a Driver's Licence, Passport, Centrelink document or other form of photo identification.

If you are seeking access to document/s on behalf of another person or organisation, a signed and dated statement of authority must be included with the application.

If you are seeking access to documents relating to a deceased party, proof of closest/nearest relative status may be requested.
