General Information

- Temporary Permits are issued for 3 months or part thereof, a fee applies (please refer to website for the fee) and can be paid by credit card over the phone. Once payment has been received, the Temporary Permit will be posted out to the recipient with a receipt for the amount paid.
- A permit may be renewed for a term of up to 3 months on application made before the end of the term of the permit or within 3 months after the end of that term. After that time the permit cannot be renewed but the person can apply for a new permit.
- A permit must not be granted or renewed to authorise a person to possess or use any particular firearm for more than 6 months in any period of 12 consecutive months.
- · Identification must be provided with any application for a permit.
- Interstate Group Permits incur a fee as per the schedule for those issued under r.213
- Applicants for a Temporary Possess or Possess and Use or are not required to complete Part C. This only relates to Interstate / International Group Permit, when clubs and other groups are traveling together.
- Interstate and overseas applicants must include a copy of their Firearms Licence, Club Memberships and proof of any Shooting Permissions from Land Owners to support their genuine need for the permit.
- Temporary Permits relating to (First time imports) B709 Importation Permit must include the pre-arranged pickup date given to them
 by Australian Customs, and include full Registered Firearm Dealer details of where the firearm will be delivered to for storage, pending
 licensing.
