## Notice Nominated supervisor

### Form 70

#### Use of this form

This form is to be used by building service contractors that are in partnership or company structures to notify the Building Services Board when a contractor adds, replaces or removes a nominated supervisor.

#### Legislative requirements for contractors

A building service contractor is required by the *Building Services (Registration) Act 2011* to have at least one nominated supervisor for each class of building service provided by the contractor.

#### Eligibility to be a nominated supervisor

To be eligible to be a nominated supervisor a person must be a registered building service practitioner, either:

- registered building practitioner;
- registered painting practitioner; or
- registered building surveying practitioner.

## Notifying the Board of a change, addition or the removal of nominated supervisor

The Board requires information about every change of nominated supervisor to maintain the register of building service providers.

## Notifying the Board of a cessation of a nominated supervisor

A building service contractor must notify the Board within seven days if it ceases to have a nominated supervisor.

#### Effect of not having a nominated supervisor

A building service contractor must not carry out, or undertake to carry out, a relevant building service during any period in which the contractor does not have a nominated supervisor.

#### Nominated supervisor employment status

A nominated supervisor must be a partner, director of a body corporate or an employee of the building service contractor.
