Building Services Board Policy Equivalent qualification – building surveying practitioner (level 1 and level 2) and building surveying practitioner technician

OBJECTIVE

The objective of this policy is to guide members of the Building Services Board (the Board), officers with powers delegated by the Board and Licensing Services staff in making appropriate, consistent and legally defensible assessments of qualifications submitted by applicants for registration as building surveying practitioners.

SCOPE

This policy applies to all applications made for registration as a building surveying practitioner lodged under regulation 28D of the Building Services (Registration) Regulations 2011 (Regulations).

CONTEXT

Applicants seeking registration as a builder surveyor are required to have completed the qualification prescribed by the Regulations or an equivalent qualification as determined by the Board.

TERMS USED

AIBS Australian Institute of Building Surveyors.

AIBS accreditation The status of public recognition that the AIBS grants to applicants after

an assessment of qualifications and experience.

AIBS accredited

A course as described in the 'Australian Institute of Building Surveyors Academic Course Listing'.

POLICY PRINCIPLES

The following policy does not constrain the Board's capacity to depart from this policy as appropriate to the circumstances of any particular application for registration as a building surveying practitioner.

The Board revokes all previous policies describing courses equivalent to the prescribed qualification for registration as a building surveying practitioner.

POLICY IMPLEMENTATION

Licensing Services officers reporting to the Board will present assessments of qualifications and experience in a manner that conforms to this policy and will inform applicants of this policy.
