Mining Amendment Regulations 2024 - Designated Tenement Contact

Overview

The Department of Energy, Mines, Industry Regulation and Safety (DEMIRS) is seeking public comment on the draft Mining Amendment Regulations 2024.

The purpose of the draft Mining Amendment Regulations 2024 is to amend the Mining Regulations 1981 to:

- insert regulation 84G, to require applicants and holders of tenements to provide physical address details;
- insert Division 5B, with specific rules relating to designated tenement contacts (DTC);
- make consequential changes to various forms under the Mining Regulations 1981; and
- · make small administrative amendments.

The use of a DTC will facilitate communication (including electronic), digital records management, and service of documents when required.

Optional DTC fields were added to online tenement applications following 2016 legislative amendments. Industry has responded positively, with the indicative voluntary provision of DTC details at 90 per cent and authorised use of DTC email addresses provided at 85 per cent as at February 2024.

New mandatory requirements

Under the proposed regulations, the applicants and holders of a mining tenement will need to:

- provide physical current business or residential address details (r84G);
- have a DTC and provide details, including email address (r89AC, r89AD, r89AE); and
- ensure that DTC details are kept up to date (r89AC).

For existing applicants and holders there will be a 12-month transitional period starting from the commencement of the regulations.

No action is required if a DTC was voluntarily nominated and holder address details were provided previously, provided that the details have not changed.

There are penalties of up to \$20,000 if the applicant or holder fails to provide or maintain the required information.

Providing address details and nominating a DTC

For new applications and dealings

When the Mining Amendment Regulations 2024 come into force, mandatory DTC and tenement owner (including prospective owner) address fields will appear on online and legislated forms for tenement applications, transfers, and devolutions.

For pending applications and dealings and existing tenement holders

A Form 30 Application to Amend must be lodged within 12-months of the commencement date in any of the following circumstances.

- A DTC was not nominated during the voluntary DTC opt-in period.
- The tenement owner wishes to nominate a new DTC.
- Any DTC details have changed.
- The tenement owner, or prospective owner, address was not provided.
- The tenement owner, or prospective owner, address is not current.

Updating a DTC

Changes to DTC or DTC details must be lodged with the department using a Form 30 Application to Amend.

Tenement holders are responsible for ensuring their DTC and address details are up to date.

Prescribed provisions

Regulation 89AB specifies Mining Act correspondence provisions that will apply to DTCs – that is, where correspondence relating to a tenement will be sent to a DTC. A table of these is provided as Appendix A.

Other minor changes

Regulation 89C will be amended, updating the definition of JORC Code to refer to the latest version.

The requirement for notification to be sent by post is removed from regulations 118A(1), 118A(2) and 120A(3).

Consultation

The draft Mining Amendment Regulations 2024 is available for comment until close of business **27 September 2024.**
