## **Exmouth Gulf Taskforce Communique**

## Meeting 9, 23 August 2024

#### Latest news

The ninth meeting of the Exmouth Gulf Taskforce (the Taskforce) was held in Exmouth on 23 August 2024. The meeting was chaired by Mr David McFerran, Taskforce Chair.

The Taskforce discussed a range of topics, including:

- Department of Climate Change, Energy, the Environment and Water: World Heritage and National Heritage listings, nomination process and the Cape Range Subterranean Waterways
- Great Barrier Reef Marine Park Authority: governance arrangements, structure and key learnings
- Cockburn Sound Management Council: governance arrangements, structure and key learnings
- Dr Capri Jolliffe, Technical Director, JASCO, Exmouth Gulf marine soundscape baseline study
- Dr Jenny Shaw, Research Director, Western Australian Marine Science Institution: Investment Plan update
- Department of Biodiversity, Conservation and Attractions (DBCA), Exmouth Gulf marine park planning update

On 22 August, Taskforce Members received presentations on the unique birdlife of Exmouth Gulf and the karst system. Members also visited potential Water Corporation sites for groundwater expansion and desalination options, as well as visiting Defence sites.

The Taskforce also hosted a Community Information Forum in Exmouth on 21 August 2024, with 46 people attending. The Forum covered: an overview of the 2021 Environmental Protection Authority strategic advice and government's response; Exmouth Gulf Taskforce establishment and Terms of Reference; Taskforce current work and next steps and DBCA's Plan for Parks activities in the Gulf region and next steps for the 2021 government commitments for the Exmouth Gulf Marine Park (southern and eastern Gulf).

The Taskforce was pleased with the attendance along the level of knowledge and understanding demonstrated by the attendees. The Taskforce noted the attendees views on the extent and level of protection for an Exmouth Gulf Marine Park.
