
Licensing and approvals





In Quarter 3, 2016–17 (the quarter):

- The Department of Environment Regulation (DER) decided 100 per cent (of 1 in total) of major resource projects' works approval applications within the 60 working day target.
- No new applications were received and one application was not decided by the end the quarter.
- The average time for decisions was 49 working days.



Major resource projects – licence applications

In the quarter:

- DER did not decide any major resource projects' licence applications.
- Two new applications were received and six applications were not decided by the end of the quarter.

Other projects – works approval applications



In the quarter:

- DER decided 64 per cent (11 in total) of other project works approval applications within the 60 working day target.
- 16 new applications were received and 40 applications were not decided by the end of the quarter.
- The average time for decisions was 56 working days.



Other projects - licence applications

In the quarter:

- DER decided 38 per cent (8 in total) of other project licence applications within the 60 working day target.
- 18 new applications were received and 65 applications were not decided by the end of the quarter.
- The average time for decisions was 108 working days.


Native vegetation clearing permit applications



Applications decided

In the quarter:

- DER decided 74 per cent (of 72 in total) of native vegetation clearing permit applications within the 60 working day target.
- 99 new applications were received and 163 applications were not decided by the end of the quarter.
- The average time for decisions was 48 working days.



Hectares granted or refused

In the quarter:

DER refused 1 hectare (1 application) and granted 91 hectares (48 applications).

Contaminated sites




In the quarter:

- DER processed 100 per cent (of 83 in total) of Form 1s within the 45 calendar day target.
- 58 new Form 1s were received and 6 were not decided by the end of the quarter.

Compliance and Enforcement

Compliance program 2016–17



In the quarter:

• DER's annual compliance program achieved 66 per cent (825) of its annual target (1245) by the end of the quarter.



Controlled waste licences

In the quarter:

DER assessed 100 per cent (122 applications) within the 30 calendar day statutory target.



Enforcement activity

In the quarter:

- DER finalised 68 per cent of investigations* (604 out of 894 in total) within the 60 working day target.
- There were 974 new matters recorded.
- The average time taken to finalise matters was five calendar days.
- * Matters investigated can include but are not limited to: complaints/incidents relating to emissions and discharges, controlled waste transportation, clearing of native vegetation, illegal dumping as well as issues identified by Departmental officers through the course of their duties.

Q1, Q2 and Q3 16-17: These figures have been updated using a revised methodology to more accurately capture matters being investigated by the Department.
