Women's Report Card:

Measuring Women's Progress Update 2006

In 2004 the Women's Report Card established a set of indicators measuring progress in the lives of women in Western Australia. The following report provides an update of those indicators.

The choice of indicators in the Women's Report Card was influenced by community engagement with women, existing policy issues, national and international indicators and by the availability of relevant and reliable data. The indicators are drawn from around 50 different sources and the data is released at intervals ranging from quarterly to every four years. Current data availability has allowed for 86 per cent of indicators to be updated. Some indicators have been improved through data sources and other refinements.

Unless otherwise stated all figures relate to women (aged 15+) in Western Australia.
