2015/17 Perth and Peel Land Use and Employment Survey

The **Land Use and Employment Survey** is undertaken to support the Department of Planning, Lands and Heritage and the Western Australian Planning Commission's strategic planning processes, and in particular, to assist in the review of principles, policies and modelling relating to land uses in different locations. The survey collects key information relating to land use and employment, including the type of activities conducted

by businesses, how much floorspace the activity occupies and how many people are employed in each activity. This information is crucial in informing the Department's employment forecasting and transport modelling. It is anticipated that the data will continue to be widely used by a range of stakeholders across State and local government, academic institutions and consultancies.

Survey rate

The survey achieved an overall response rate of 90 per cent. Data has been extrapolated for to account for responses that could not be attained.

From February 2015 to November 2016, nearly 157,000 activities were captured – 44,500 more than recorded in the 2007/09 Perth and Peel Land Use and Employment Survey.



Perth and Peel land uses

Data captured by the survey reveals the Perth metropolitan and Peel regions have a total floorspace of almost **50 million square metres**. The central sub-region showed the highest total amount of occupied floorspace at 57 per cent, while the Peel sub-region showed the lowest total amount of occupied floorspace at three per cent.

The Perth metropolitan and Peel regions have three main uses of floorspace: storage/distribution (8.5 million square metres), office/business (seven million square metres) and health/welfare/community services (7.5 million square metres). Together, these land uses occupy almost 50 per cent of all floorspace.

Occupancy rate by sub-region


3 Occupancy

There has been a 35 per cent increase in the total floorspace captured since the 2007/09 Perth and Peel Land Use and Employment Survey, with a 2.4 per cent increase in vacant floorspace within the same timeframe.

The Perth metropolitan and Peel regions had a vacancy rate of 8 per cent across all land uses, with 62 per cent of all vacant floorspace located within the central sub-region. The City of Perth had a 12 per cent vacancy rate across all land uses.

City of Perth end of trip facilities

The 2015/17 survey also captured which buildings provide end of trip facilities and bicycle bays for employees. Of nearly 3,000 buildings surveyed in the City of Perth, more than half provide end of trip facilities for employees who cycle and/or walk to work. In addition, 3,300 designated bicycle bays exist across these buildings.
