Introduction to Metropolitan Region Scheme minor amendments

The Western Australian Planning Commission (WAPC) is responsible for keeping the Metropolitan Region Scheme under review and initiating changes where they are seen as necessary.

The Metropolitan Region Scheme (MRS) sets out the broad pattern of land use for the whole Perth metropolitan region. The MRS is constantly under review to best reflect regional planning and development needs.

An amendment proposal to change land use reservations and zones in the MRS is regulated by the *Planning and Development Act 2005*. That legislation provides for public submissions to be made on proposed amendments.

For a non-substantial amendment, often referred to as a minor amendment (made under section 57 of the Act), the WAPC considers all the submissions lodged, and publishes its recommendations in a report on submissions. This report is presented to the Minister for Planning for approval. The amendment takes legal effect with Gazettal of the Minister's approval.

In the process of making a non-substantial amendment to the MRS, information is published as a public record under the following titles:

Amendment report

This document is available from the start of the public advertising period of the proposed amendment. It sets out the purpose and scope of the proposal, explains why the amendment is considered necessary, and informs people how they can comment through the submission process.

Environmental review report

The Environmental Protection Authority must consider the environmental impact of an amendment to the MRS before it can be advertised. While formal assessment would be unlikely for a non-substantial amendment, were it required then an environmental review would be undertaken and made available for information and comment at the same time as the amendment report.

Report on submissions

The planning rationale, determination of submissions and the WAPC's recommendations for final approval of the amendment, with or without modification, is documented in this report.

This document contains a reproduction of all written submissions received by the WAPC on the proposed amendment.

1 Introduction

At its February 2020 meeting, the Western Australian Planning Commission (WAPC) resolved to proceed with this amendment to the Metropolitan Region Scheme (MRS) in accordance with the provisions of Section 57 of the *Planning and Development Act 2005*.

The amendment was initiated as a minor amendment to the MRS as the proposal was considered to be relatively minor in nature. The reasons for that decision are included in the previously published *Amendment Report* for this amendment.

2 The proposed amendment

Purpose

The amendment proposal was described in the previously published *Amendment Report* and a description of the proposal is repeated below.

The purpose of the amendment is to rezone approximately 9.93 ha of land in Wandi from the Urban zone to the Public Purposes - High School reservation under the MRS, as shown on the figure for Proposal 1.

The amendment will facilitate the planning and development of a future high school on the subject land.

3 Environmental Protection Authority advice

On 15 May 2020, the Environmental Protection Authority (EPA) determined that the amendment did not require assessment under Part IV of the *Environmental Protection Act 1986* and provided advice on flora and vegetation environmental factors relevant to the amendment area.

The EPA advised that the amendment area contains the 'Banksia dominated woodlands of the Swan Coastal Plain' priority ecological community (PEC) and is located adjacent to an occurrence of the 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' threatened ecological community (TEC). The EPA also advised that development of the amendment area should be informed by the outcomes of relevant environmental and hydrological studies, and recommended that any future structure planning be supported by a vegetation survey to inform whether any remnant vegetation needs to be retained.

The EPA concluded that the amendment could be managed to meet its environmental objectives through existing planning controls, and recommended its advice is implemented to mitigate potential impacts to flora and vegetation.

A copy of the notice from the EPA is in Appendix A of the *Amendment Report*.

4 Call for submissions

The amendment was advertised for public submissions from 3 July 2020 to 4 September 2020.

The amendment was advertised for public inspection during ordinary business hours at the:

- i) Western Australian Planning Commission, 140 William Street, Perth
- ii) City of Kwinana
- iii) State Reference Library, Northbridge.

During the public inspection period, notice of the amendment was published in the *West Australian* and relevant local newspaper/s circulating in the locality of this amendment.

5 Submissions

Forty-Two submissions (includes one late submission) were received on the amendment. An alphabetical index of all persons and organisations lodging submissions is at Schedule 1.

Twenty-seven submissions supported the amendment, with eight of these submissions providing comment on the amendment. Two submissions opposed the amendment, with one of these submissions providing comment. Thirteen submissions were received from State Government agencies, the City of Kwinana and servicing agencies, which either supported, provided comment or raised no objection to the amendment.

A summary of each submission with WAPC comments and determinations is at Schedule 2. A complete copy of all written submissions is contained in this report.

6 Main issues raised in submissions

6.1 Impact of future development on the 'Banksia Woodlands of the Swan Coastal Plain' PEC

The amendment area contains remnant vegetation which may form part of the 'Banksia Woodlands of the Swan Coastal Plain' PEC, and consideration should be given to retaining remnant vegetation in subsequent planning stages.

WAPC Comment: Once the amendment area is reserved Public Purposes - High School under the MRS, there will be no requirement for the Department of Education to obtain development approval under the MRS for the construction of a high school on the site. This is because a high school is defined as permitted development on Public Purposes - High School reserved land in the MRS.

However, the statutory requirements of the Environmental Protection Act 1986 (EP Act), the Biodiversity Conservation Act 2016 (BC Act) and the Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act) should provide for the appropriate protection of any significant environmental values within the amendment area. In this respect:

- (a) Any clearing of remnant native vegetation within the amendment area is likely to require a clearing permit pursuant to the requirements of the EP Act.*

- (b) *Part of the remnant native vegetation within the amendment area is classified as potentially being part of the 'Banksia Woodlands of the Swan Coastal Plain' PEC. Section 45 of the BA Act requires a proponent to obtain authorisation for any actions which proposed to modify or alter a PEC.*
- (c) *Part of the remnant native vegetation within the amendment area is potentially part of the 'Banksia Woodlands of the Swan Coastal Plain' PEC. As such, any development which may impact on vegetation which forms part of this PEC may require referral to the Commonwealth Department of Agriculture, Water and the Environment, pursuant to the requirements of the EPBC Act.*

Submissions noted.

6.2 Impact of future development on the 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' TEC

The future development of the amendment area may result in adverse impacts on the environmental values of the 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' TEC located to the south of the amendment area.

WAPC Comment: *As discussed above, the future development of a high school within the amendment area will not require development approval under the MRS, once the site is reserved Public Purposes - High School under the MRS. As a result, there are no subsequent stages of the planning process which could consider the appropriate protection of the environmental values of the 'Community of Tumulus Springs' TEC.*

However, any future development of the amendment area which could potentially impact upon the environmental values of this TEC, are likely to be subject to the requirements of the EP Act, BC Act, and EPBC Act as outlined in the previous section. The requirements of this environmental legislation should be sufficient to ensure that the future development of the site does not adversely impact on any significant environmental values of this occurrence of the 'Community of Tumulus Springs' TEC.

Submissions noted.

7 Determinations

The responses to all submissions are detailed in Schedule 2 - *Summary of submissions and determinations*. It is recommended the amendment be adopted for finalisation as advertised.

8 Coordination of region and local scheme amendments

Under section 126(3) of the *Planning and Development Act 2005* the WAPC has the option of concurrently rezoning land that is being zoned Urban under the MRS, to a "Development" zone (or similar) in the Local Planning Scheme. As no land is being zoned Urban by the amendment, Section 126(3) is not applicable to the amendment.

9 Conclusion and recommendation

This report summarises the background to MRS minor amendment 1368/57 and examines the various submissions made on it.

The WAPC, after considering the submissions, is satisfied that the advertised amendment as shown generally on the Amendment Figure – Proposal 1 in Schedule 3, and in detail on the MRS Amendment Plan listed in Appendix 1, should be approved and finalised.

Having regard to the above, the WAPC recommends that the Minister for Planning approves the amendment.

10 Ministers decision

Amendments to the Metropolitan Region Scheme using the provisions of section 57 of the *Planning and Development Act 2005* require the WAPC to provide a report and recommendation to the Minister for Planning for approval. The Minister may approve, approve with modification or decline to approve the proposed amendment.

The Minister, after considering the amendment, has agreed with the recommendation of the WAPC and approved the amendment.

MRS Amendment 1368/57 is now finalised as advertised and shown on WAPC Amending Plan 3.2757 and has effect in the Metropolitan Region Scheme from the date of notice in the *Government Gazette* on 8 February 2022.

The Water Corporation provides comments in regard to the following matters:

- (a) Water: Reticulated water is currently available to the subject area. All water main extensions, if required for the development site, must be laid within the existing and proposed road reserves, on the correct alignment and in accordance with the *Utility Providers Code of Practice*.
- (b) Wastewater: Reticulated sewerage is currently available to the subject area. All sewer main extensions, if required for the development site, should be laid within the existing and proposed road reserves, on the correct alignment and in accordance with the *Utility Providers Code of Practice*.
- (c) Drainage: The subject area falls within the Peel Drainage Catchment in the Mundijong Drainage District, a rural drainage system. Developments within this catchment are required to contain the flows from a one in one hundred year storm event on site. Discharge to Water Corporation drains must be compensated to pre-development levels. At the time of development the developer may be required to provide calculations from a consulting engineer to demonstrate, to our satisfaction that the runoff from the development has been restricted to pre development levels.
- (d) General Comments: The developer is expected to provide all water and sewerage reticulation if required. A contribution for water and sewerage headwords may also be required. In addition, the developer may be required to fund new works or the upgrading of existing works and protection of all works.

Planning Comment: Comments noted. It is noted that reticulated water and sewerage services are available to the amendment area. All other matters raised by the Water Corporation can be addressed when any future development works are undertaken within the amendment area.

The Department of Education (DoE) advises that it reserves its support of the amendment until the following matters can be resolved, or an alternative high school site is identified in the locality which accords with the design principles of *Development Control Policy 2.4: School Sites* (DCP 2.4) and draft Operation Policy 2.4: Planning for School Sites (OP 2.4).

- (a) The DoE undertook a comprehensive assessment and engagement process with the City of Kwinana and the proponent to identify the school site as part of the preparation of the *Wandi South Local Structure Plan* (LSP). Notwithstanding this, significant concerns still remain outstanding in relation to the ability for a secondary school to be accommodated on the subject land.
- (b) The amendment report identifies the following constraints that may affect the subject site:
- the possible requirement to retain remnant vegetation on the site.
 - the subject land is located on an identified wetland.

- the public open space located to the south of the amendment area contains a known occurrence of the 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' TEC, which is listed as critically endangered. The Department of Biodiversity, Conservation and Attractions recommends hydrological investigations be undertaken prior to detailed site planning to assist in the understanding of the local hydrology and potential impacts to the TEC.

The presence of the above constraints has significant impact on the ability of the DoE to deliver an effective 10 hectare public secondary school site and will likely result in a substantial cost to bring the amendment area to a developable standard.

- (c) In addition to DCP 2.4, the DoE has given due consideration to the relevant provisions of draft OP 2.4. In particular, clause 3.4.1 of draft OP 2.4 states that land should have sufficient developable area to be unencumbered to the following extent:
- a) be level, although gently sloping sites may be acceptable;
 - b) not have extreme topographical features involving extensive on-site earthworks, retaining and/or importation of fill;
 - c) not require any clearing of native vegetation and/or need State or Australian Government environmental approvals or offsets, or intend/propose for significant areas of vegetation to be retained;
 - d) be geotechnically sound and not containing geological features that would affect development, or be subject to inundation or erosion; and
 - e) have appropriately assessed and managed any flooding or bushfire risks.
- (d) In its current form, the identified secondary school site does not comply with the requirements of DCP 2.4 or the draft OP 2.4 and it is unknown as to whether it will be able to accommodate its intended future use.

Planning Comment:

- (b)-(d) Comments noted. However, the DoE has since provided further advice on the amendment, in which it advises that it supports finalisation of the amendment. The Department also advises that it has undertaken environmental and site investigations for the amendment area which have not identified any signification constraints for the site, apart from the significant costs for civil works and fill.

Also, refer to Parts 6.1 Impact of future development on the 'Banksia Woodlands of the Swan Coastal Plain' PEC and 6.2 Impact of future development on the 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' TEC.

The Department of Biodiversity, Conservation and Attractions (DBCA) provides the following comments on the amendment:

- (a) DBCA previously provided comment on the proposed MRS amendment. No additional information has been provided with the current referral regarding the site's existing or surrounding environmental values, the proposed detailed development design or potential environmental impacts from a change in land use.
- (b) The amendment area is directly north of an occurrence of the 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' TEC. This TEC is listed as critically endangered in Western Australia and Endangered under the Commonwealth EPBC Act. The TEC is hydrologically sensitive.

Appropriate mitigation measures should be identified to manage potential direct and indirect impacts to the TEC, such as a reduction in the TEC's surface water catchment, increased nutrients entering groundwater and/or a lowering of groundwater levels. Future planning processes should address the management of any development impacts and should include the preparation of a management plan that includes monitoring of the TEC to assess impacts to hydrology, ecosystem function and vegetation composition and considers contingency actions such as sourcing alternate water sources for irrigation and revising on-site stormwater management.

The likely impacts to the TEC from the current proposed change in land use, need to be considered in the context of current and future regional hydrological conditions.

- (c) DBCA understands that groundwater abstraction (approximately 30,000 kL per year) may be required to facilitate irrigation of turfed areas associated with the high school development. In addition, dewatering may also be required as part of the high school development. The approval of an abstraction and/or dewatering licence by the Department of Water and Environmental Regulation should be informed by hydrological studies that demonstrate the potential impacts to the TEC. Investigations into surface and groundwater management, other than the required groundwater abstraction, should be undertaken prior to construction to inform the detailed design and should be ongoing, during and post construction, with relevant contingency actions identified and implemented.
- (d) In the absence of relevant hydrological investigations and an understanding of the current regional hydrology, DBCA is unable to provide advice regarding potential impacts to the TEC as a result of the proposed change in land use.

- (e) An appropriate mechanism, to ensure that relevant studies are undertaken and considered prior to the detailed design of the high school site and future planning approvals, should be identified as part of the scheme amendment process.

It is likely that the proponent would need to undertake the relevant hydrological studies to investigate the impacts of any water extraction on the environmental values of the TEC. It is anticipated that DWER would appropriately consider the findings and recommendations of any such hydrological studies in its assessment of any groundwater extraction or dewatering licence submitted for the amendment area. This should ensure that any significant environmental values of the TEC are appropriately protected.

Main Roads Western Australia (MRWA) provides the following comments on the amendment:

- (a) A transport impact assessment, in accordance with the WAPC *Transport Impact Assessment Guidelines Volume 4 - Individual Developments* must be undertaken at the development application stage for the school to determine the impact on Anketell Road, specifically the intersection of Spine Road and Lyon Road.
- (b) Westport has identified Anketell Road and Thomas Road as the preferred road freight access for the future container port in Kwinana. Preliminary concept plans for Anketell Road are enclosed for information to assist with the traffic assessment. The plans will be reviewed during detailed planning for Anketell Road to be undertaken as part of the next phase of the Westport Study.

Planning Comment: Comments noted. Transport planning matters relating to the detailed design and construction of a future high school within the amendment area are most appropriately addressed when any future development is undertaken within the amendment area.

The City of Kwinana provides the following comments on the amendment:

- (a) The proposal is consistent with the land area and zonings set out in the approved *Wandi South Local Structure Plan*. As part of the assessment of this Local Structure Plan, the City and the Department of Education agreed to share the high school playing fields, providing the community with access to active open space after school hours. The City also outlines the facilities which the high school playing fields are expected to contain.
- (b) The amendment area provides habitat for a significant number of native fauna. The local community has a proactive interest in the site and conservation reserves immediately to the north and south of the site.

The community have produced evidence of aquatic and terrestrial fauna that migrate between Cordata Wetlands, the amendment area and conservation reserves on Lots 8025 and 8045 Honeywood Avenue. The fauna species include Priority 3 Isoodon obesulus [Southern Brown Bandicoot]. Accordingly, consideration of fauna movement in and around the subject site should include the retention of the best quality habitat on the proposed school site and underpasses for road crossings with vegetated corridors between sites.

- (c) The north-eastern end of the amendment area is mapped as containing the 'Banksia Woodlands of the Swan Coastal Plain' PEC, and contains Priority 3 Fauna - Isoodon obesulus. The best condition vegetation within the amendment area should be retained for fauna habitat.
- (d) Clearing of the balance of vegetation within the amendment area will require fauna relocation and management by a suitably qualified professional.

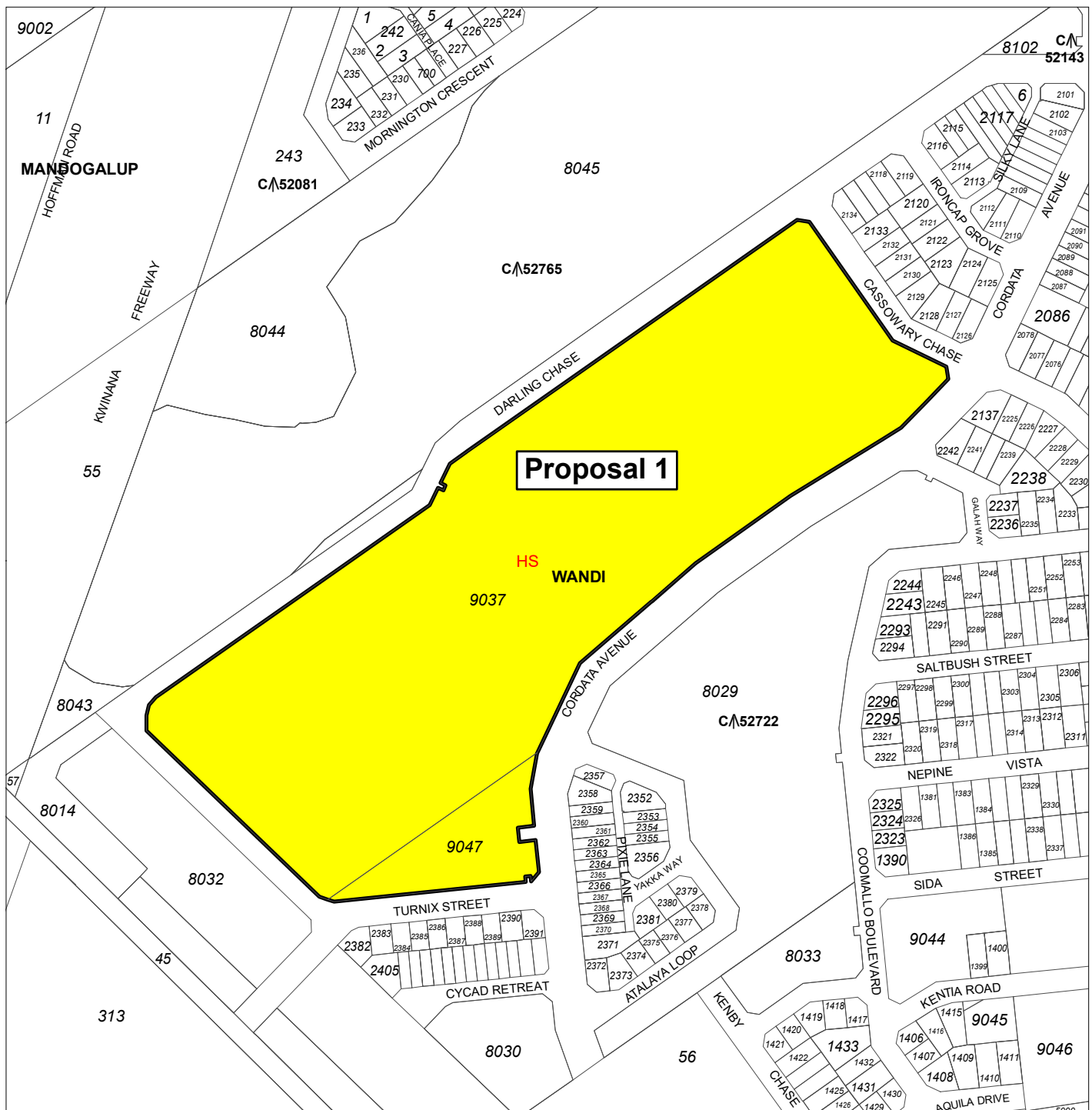

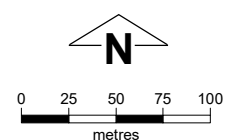

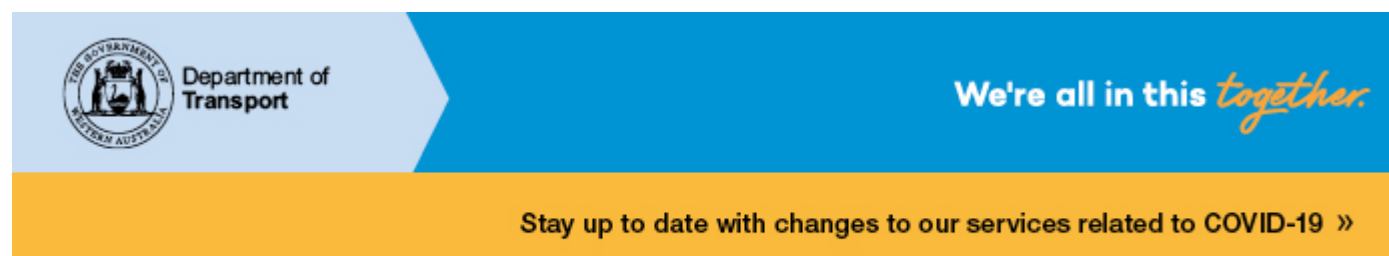

Thank you for your referral received with correspondence dated 30 June 2020 requesting comment upon the abovementioned proposed amendments to the Metropolitan Region Scheme.

The Department has reviewed the information provided and wishes to advise that it does not object to the proposed initiation of amendments to the Metropolitan Region Scheme. The following advice is provided.

1367/5 7 - Part Lot 5131 Jandakot Road, Treeby and Surrounds

This site is located within a Priority 2 public drinking water source area (PDWSA) of the Jandakot Underground Pollution Control Area (UWPCA). Land planning decisions are made in accordance with *State Planning Policy 2.3: Jandakot Groundwater Protection* (SPP 2.3), and a land use such as urban development is generally considered incompatible due to the risk of contamination to the water source.

However, Section 6.3(c) of SPP 2.3 states that proposals which satisfy the following criteria may be supported:

- Large landholdings that were previously cleared and disturbed;
- Land directly adjacent to already developed areas;
- Land identified as being appropriate for more intensive development through strategic planning instruments such as a regional or sub-regional structure plan.

The subject land is a former sand quarry and the proposed urban area is largely cleared of vegetation, adjacent to existing urban development and is identified in the *South*

Metropolitan Peel sub-regional planning framework as Open Space and Urban Investigation.

The proposal is considered to satisfy the aforementioned criteria of SPP 2.3, and as such the Department would not object to the proposed amendment should it be initiated.

The amendment report also identifies that the *Treeby (Banjup) - Strategic District Water Management Strategy (JDA, 2017)* has been previously endorsed by the Department. The report demonstrates that water management measures are appropriate for a Priority 3 PDWSA, in the event an urban rezoning is initiated, and as such requirements of *State Planning Policy 2.9: Water Resources* and *Better Urban Water Management (WAPC, 2008)*, have been satisfied.

1368/57 - Wandi High School Site

Previous water planning in accordance with *State Planning Policy 2.9: Water Resources* and *Better Urban Water Management (WAPC, 2008)* have identified a school site in this location. Furthermore, there is currently a groundwater licence entitlement confirmed for irrigation of the school oval. As such the Department has no objections to this amendment being initiated.

Water

Reticulated water is currently available to the subject area. All water main extensions, if required for the development site, must be laid within the existing and proposed road reserves, on the correct alignment and in accordance with the Utility Providers Code of Practice.

Wastewater

Reticulated sewerage is currently available to the subject area. All sewer main extensions, if required for the development site, should be laid within the existing and proposed road reserves, on the correct alignment and in accordance with the Utility Providers Code of Practice.

Drainage

The subject area falls within the Peel Drainage Catchment in the Mundijong Drainage District, a rural drainage system. Developments within this catchment are required to contain the flows from a one in one hundred year storm event on site. Discharge to Water Corporation drains must be compensated to pre-development levels. At the time of development the developer may be required to provide calculations from a consulting engineer to demonstrate, to our satisfaction that the runoff from the development has been restricted to pre development levels.

Thank you for your letter dated 30 June 2020 providing the Department of Education (Department) with the opportunity to comment on Metropolitan Region Scheme (MRS) Amendment No. 1368/57.

The Department undertook a comprehensive assessment and engagement process with the City of Kwinana and the proponent to identify the school site as part of the preparation of the Wandi South Local Structure Plan (LSP). Notwithstanding this, significant concerns still remain outstanding in relation to the ability for a secondary school to be accommodated on the subject land.

The amendment report identifies the following constraints that may affect the subject site:

- the possible requirement to retain remnant vegetation on the site;
- the subject land is located on an identified wetland; and
- the public open space located to the south of the subject land contains an occurrence of the Threatened Ecological Community (TEC) known as 'Community of Tumulus Springs', which is listed as a Critically Endangered. The Department of Biodiversity, Conservation and Attraction recommends that hydrological investigations be undertaken prior to detailed site planning to assist in the understanding of the local hydrology and potential indirect impacts to the TEC.

The presence of the above constraints has significant impact on the ability of the Department to deliver an effective 10 hectare public secondary school site and will likely result in a substantial cost to bring the subject land to a developable standard. In addition to the WAPC Development Control Policy 2.4 – School Sites (DCP 2.4), the Department has given due consideration to the relevant provisions of the currently advertised draft Operational Policy 2.4 - Planning for School Sites (OP 2.4), in particular, clause 3.4.1 of draft OP 2.4 states that land should have sufficient developable area and be unencumbered to the following extent:

- a) *be level, although gently sloping sites may be acceptable;*
- b) *not have extreme topographical features involving extensive on-site earthworks, retaining and/or importation of fill;*

- c) *not require any clearing of native vegetation and/or need State or Australian Government environmental approvals or offsets, or intend/propose for significant areas of vegetation to be retained;*
- d) *be geotechnically sound and not containing geological features that would affect development, or be subject to inundation or erosion; and*
- e) *have appropriately assessed and managed any flooding or bushfire risks.*

In its current form, the identified secondary school site does not comply with the requirements of DCP 2.4 or the draft OP 2.4 and it is unknown as whether it will be able to accommodate its intended future use. Accordingly, the Department reserves its support of the MRS amendment until the above matters can be resolved and/or that an alternative site within the locality, which accords with the school design principles of the above policies, is identified.

I refer to your correspondence of 30 June 2020, requesting comments on the proposed Metropolitan Region Scheme (MRS) amendment to rezone an area in Wandi from the Urban zone to the Public purpose – High School reservation. The Parks and Wildlife Service at the Department of Biodiversity, Conservation and Attractions reviewed the referred information and provides the following advice.

A previous request for comment on the proposed MRS amendment was referred by the Western Australian Planning Commission in January 2020. DBCA subsequently provided the attached advice on the amendment dated 2 February 2020. No additional information was provided with the current referral regarding the site's existing or surrounding environmental values, the proposed detailed development design or potential environmental impacts from a change in land use.

DBCA's previous advice, which is referenced in the amendment report, identified that the subject site is directly north of an occurrence of the threatened ecological community (TEC) known as 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)'. This TEC is listed as Critically Endangered in Western Australia and Endangered under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999*. The TEC is hydrologically sensitive and occurs in an area of public open space directly south of the proposed high school site.

Appropriate mitigation measures should be identified to manage potential direct and indirect impacts to the TEC such as a reduction in the TEC's surface water catchment, increased nutrients entering groundwater and/ or a lowering of groundwater levels. Future planning processes should address the management of any development impacts and should include the preparation of a management plan that includes monitoring of the TEC to assess impacts to hydrology, ecosystem function and vegetation composition and considers contingency actions such as sourcing alternate water sources for irrigation and revising on-site stormwater management. The likely impacts to the TEC from the current proposed change in land use, need to be considered in the context of current and future regional hydrological conditions.

DBCA understands that groundwater abstraction (approximately 30 000 kilolitres per year) may be required to facilitate the irrigation of turfed areas associated with the high school development. In addition, dewatering may also be required as part of the high school development. The approval of

an abstraction and/ or dewatering licence by the Department of Water and Environmental Regulation should be informed by hydrological studies that demonstrate the potential impacts to the TEC. Investigations into surface and groundwater management, other than the required groundwater abstraction, should be undertaken prior to construction to inform the detailed design and should be ongoing, during and post construction, with relevant contingency actions identified and implemented.

In the absence of relevant hydrological investigations and an understanding of the current regional hydrology, DBCA is unable to provide advice regarding potential impacts to the TEC as a result of the proposed change in land use. An appropriate mechanism, to ensure that relevant studies are undertaken and considered prior to the detailed design of the high school site and future planning approvals, should be identified as part of the scheme amendment process.

Proposed Metropolitan Region Scheme Amendment – Wandi High School – Request for Preliminary Comment

I refer to your correspondence of 17 January 2020, requesting comments on the proposed Metropolitan Region Scheme (MRS) amendment to rezone an area in Wandi from 'Urban' to 'Public purpose – High School' reservation. It is noted no information was provided with the referral regarding the site's environmental values or potential impacts from a change in land use. The Parks and Wildlife Service at the Department of Biodiversity, Conservation and Attractions has therefore drawn from existing knowledge and departmental records in providing the following advice.

The amendment area abuts a recently identified occurrence of the threatened ecological community (TEC) known as 'Community of Tumulus Springs (Organic Mound Springs, Swan Coastal Plain)' which is listed as Critically Endangered in Western Australia and Endangered under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999*. The TEC occurs in an area of public open space south of the high school site and is separated from the development by a constructed local road.

The TEC is hydrologically sensitive and while the community may already be subject to impacts as a result of the current surrounding residential development, further hydrological impacts should be avoided. Consideration should be given to avoiding any hydrological (water quality and quantity) impacts to the TEC including the potential changes to groundwater levels, surface water flows and any reduction of the local mound spring catchment. It is recommended that hydrological investigations be undertaken to assist in understanding the local hydrology (surface water and groundwater) and potential indirect hydrological impacts to the TEC. Investigations should be conducted prior to detailed site planning to determine appropriate buffer distances and management measures that may be required ensure protection of the TEC.

While the potential impacts to the TEC should be identified and considered in future planning processes, the proposed MRS amendment to change the land use from 'Urban' to 'Public purposes' could be considered in the absence of detailed hydrological assessments, provided future stages of planning address this issue.

The plans will be reviewed during detailed planning for Anketell Road to be undertaken as part of the next phase of the Westport Study.

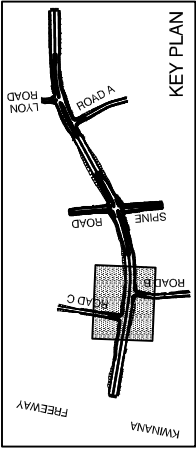
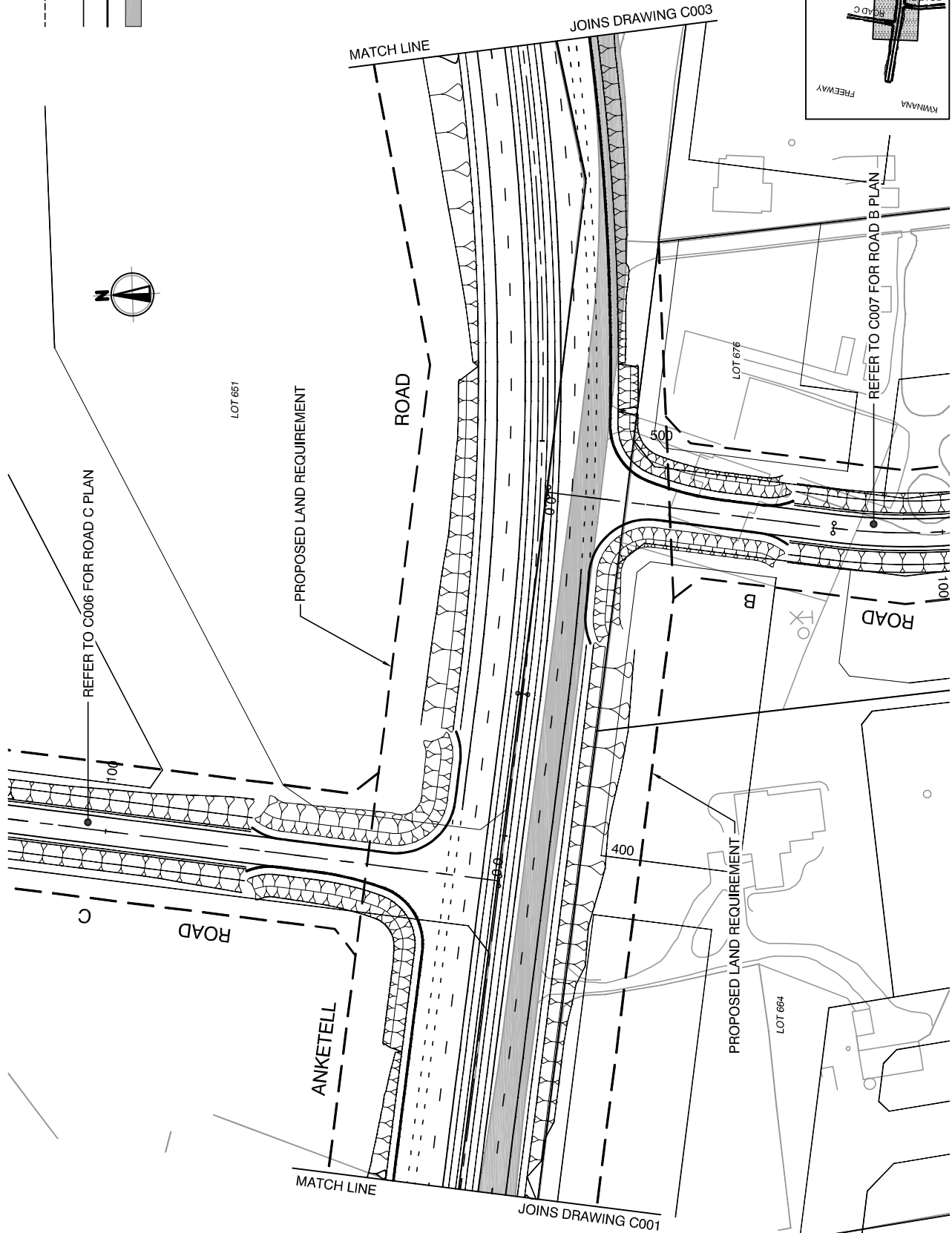

PROPOSED MRS AMENDMENT – 1368/57 – WANDI HIGH SCHOOL SITE – URBAN TO PUBLIC PURPOSE – HIGH SCHOOL

Thank you for your letter, received 7 August 2020, seeking comment on the proposed amendment to rezone Wandi high school site from Urban to Public Purpose – High School.

The City has assessed the proposal and has following comments:

The proposal is consistent with the land area and zonings as set out under the approved Wandi South Structure Plan. As part of assessment of the local structure plan the City and the Department of Education agreed to share the High School playing fields, providing high accessibility to the local community to active open space after school hours. The High School playing fields are expected to comprise at the least the following:

- 1 x Senior football oval
- 1x cricket pitch
- 1x cricket practice nets
- 1 x sports hall of 600m² comprising 1 basketball court
- 2 x basketball / netball courts overlain at right angles with 2 x tennis courts; and
- 4 tennis courts.

With regard to fauna relocation, the site provides habitat for a significant number of native fauna. The local community have a proactive interest in the site and conservation reserves immediately to the north and south of the site. The community have produced evidence of aquatic and terrestrial fauna at the site that migrate between Cordata Wetlands, the subject site and conservation reserves on Lots 8045 & 8025 Honeywood Avenue. Fauna species include Priority 3 *Isoodon obesulus*.

Accordingly, consideration of fauna movement in and around the subject site should include the retention of the best quality habitat on the proposed school site and underpasses for road crossings with vegetated corridors between sites.

Further, the north-eastern end of the subject site is mapped as a Threatened Ecological Community Banksia Woodlands and contains Priority 3 Fauna - Isoodon obesulus. Retention of the best condition vegetation on the Lot should be retained for fauna habitat.

Clearing of the balance of vegetation on the site will require fauna relocation and management by a suitably qualified professional.
