



# SEMC COMMUNIQUE

## DECEMBER 2021 HIGHLIGHTS



The final meeting of the State Emergency Management Committee (SEMC) for 2021 was on Friday 3 December.

The key items from the meeting are summarised below.

### Discussion Items and Outcomes

The [2021 – 2024 SEMC Strategic Plan](#) has been released and is now available on the SEMC website.


The [2020 – 2021 SEMC Annual Report](#) has also been finalised and will be published on the SEMC website shortly.

The SEMC received two presentations. The first was on the risk of Coastal Inundation presented by the WA Local Government Association. The risks of coastal inundation to key low-lying areas in the south west of WA are caused by increased storm intensity (winter and summer cyclones), which can be mitigated by the preparation level of these communities. SEMC noted the Department of Transport's work on vulnerable inundation 'hotspots', which informed this presentation.

The second presentation was from the Department of Mines, Industry, Regulation and Safety. An overview of WA's transportation and regulation of dangerous goods was provided, and how it is being managed to prevent risks to the community and emergency management sector.

The SEMC noted the Shire of Harvey's case study on 'Long Tail' Recovery following the 2016 Waroona Complex Fire. The case study reflected the Shire of Harvey's perspectives, reflections and roles associated with long-term recovery, including how they organised their own people, resources, governance, systems and processes over the five years since the fire. The key themes identified provide invaluable lessons for other local governments into the complexities of recovery following a significant emergency incident and noted the good preparation and planning by local governments. ### State Emergency Management Framework

- The SEMC approved four State Hazard Plans – Tsunami, Earthquake, Collapse and Maritime Transport Emergencies. The Committee noted the Communication and Marketing Strategy for each of the plans.
  - The approval of State Hazard Plans – Earthquake and Collapse concludes the Westplan Rationalisation Strategy.
  - The SEMC approved the extension of the COVID-19 State Recovery Controller's authority (under Appendix AA within the State Emergency Management Policy and State Emergency Management Plan) to continue in undertaking recovery activities and leading a whole of government approach for the duration of the term of appointment.

### Community Disaster Resilience Strategy

Consultation is continuing on the WA Community Disaster Resilience Strategy Discussion Paper. The Department of Fire and Emergency Services is seeking feedback from across the State and sectors.

State agencies, local governments, service providers and community organisations are encouraged to provide input on how a strategy would be useful for them.

## Preparing Australian Communities Program (PACP Local)

The Preparing Australian Communities Program for projects of local significance (PACP Local) is open for applications. The program will support projects that mitigate or reduce the disaster risk, impact and consequence associated with large-scale natural hazards and is coordinated by the National Recovery and Resilience Agency and administered by the Department of Industry, Science, Energy and Resources.

This round is open to a wide range of eligible applicants including local governments, community organisations and businesses across the nation. This round of the program focuses on three hazards - bushfire, flood and cyclone.

## National Flood Mitigation Infrastructure Program 2021-22

The second round of the National Flood Mitigation Infrastructure Program opened for applications on 30 November 2021. This round of the program offers \$50 million over the 2021/2022 financial year to support communities across Australia to invest in flood mitigation preparedness. Applications close on 04 February 2022. The grants are administered by the National Recovery and Resilience Agency.
