# Gazetted public drinking water source areas

## Scope

The Department of Water and Environmental Regulation (the department) is responsible for managing and protecting Western Australia's (WA's) water resources. To protect the catchment and recharge areas of our drinking water reservoirs and bore fields, the department gazettes water reserves, catchment areas and underground water pollution control areas. Collectively, these are known as public drinking water source areas (PDWSAs).

PDWSAs are declared under the *Metropolitan Water Supply, Sewerage and Drainage Act 1909* (MWSSD Act) or the *Country Areas Water Supply Act 1947* (CAWS Act). By-laws created under these acts enable the department to manage land uses and potentially polluting activities within a PDWSA.




Figure 1: Gazetted public drinking water source areas in WA (May 2023)

This note lists and maps WA's gazetted PDWSAs (see Table 1 and Figure 1). Updates to this note will occur regularly to capture changes including new proclamations, amendments or abolitions. Also, for historical context, Table 2 provides a summary of changes since the last published version of this note and Appendix A lists PDWSAs which have been abolished, or had drinking water by-laws removed, since 2007.

This note is intended as a guide only and should not be used as a substitute for viewing the original gazettal notice. The *Government Gazette*, available from [www.legislation.wa.gov.au](http://www.legislation.wa.gov.au), should be consulted for a definitive and current status of gazetted PDWSAs.

The department progressively publishes and reviews drinking water source protection reports for each PDWSA. Some reports cover multiple PDWSAs (e.g. Serpentine Dam Catchment Area and Serpentine Pipehead Dam Catchment Area). These reports identify the boundary and characteristics of the source, examine risks to water quality (and public health) and make recommendations to protect these. Source protection reports and proclamations are two important steps the department undertakes for each PDWSA to help achieve a safe, good quality, reliable and affordable drinking water source for current consumers and future generations.
