How we will create change

Four key priorities have been identified locally to improve the wellbeing and school readiness of children living in Armadale West:



Child Development

To increase the number of children meeting developmental milestones and entering school developmentally ready.²



Family Safety

To reduce the number of children aged 0-4 who have interactions with family and domestic violence.



Maternal Health

To improve access to and attendance at antenatal services to ensure mothers are healthy and babies have the best possible start to life.



Financial Wellbeing

To increase the number of families with children aged 0-4 who have a stable home and regular, nutritional meals.

Change will be supported through focusing on improving these areas of child and family wellbeing and ensuring that services are connected, coordinated and culturally responsive.



Who will be involved

The Armadale community, State Government, the Minderoo Foundation and Telethon Kids Institute (TKI) as evidence and evaluation partner, are working in partnership to create change. The Western Australian Government participates via the Department of Communities (lead partner), Department of Education and the Department of Health.
