CLOSED WATERS NETTING (WEST OF ALBANY) NOTICE 1990

Notice No. 421

552/75.

Made by the Minister under sections 9, 10 and 11.

Citation

1. This notice may be cited as the *Closed Waters Netting (West of Albany) Notice 1990*.

Interpretation

2.1 For the purposes of this notice "sunrise" and "sunset" means the time provided by the Perth Astronomical Observatory for sunrise and sunset respectively, in Perth on the relevant day.

2.2 A reference to column 1, 2, 3, 4, or 5 is a reference to the respective column in the Schedule.

Prohibition on Taking Fish by Nets

3. Subject to clause 4, the taking of fish by means of nets in the waters specified in column 1 is prohibited other than during the times specified in column 2 for set nets and column 3 for haul nets.

Time and Means of Taking Fish

4. The fish listed in column 4 may be taken in the waters specified in column 1 at the times shown in column 4 by the means specified in column 5.

Revocation

5. Notice No. 59 published in the *Gazette* of 19 March 1982 is cancelled.

Nil	The period commencing at 1600 hours on 1 May in any year and ending at 1200 hours on 31 October in the same year.	Crabs at all times	(a) drop nets; and (b) hand scoop nets.
