If required, enclose a self-addressed Registered or Express Post envelope. Privacy considerations and personal records Certificates held by the Registry contain sensitive and personal information. The Registry allows unrestricted access for birth certificates which occurred more than 100 years ago. Any documents provided with the application may have their authenticity verified through an approved online verification service. Who can apply for a certificate Birth certificates are available to the registered person (16 years of age or over) or a parent named in the birth certificate. If you do not qualify under the Registry's Certificate Access Policy, you must provide the written consent or authority from a person entitled to the certificate and you must also provide identification for yourself and the person for whom you are acting.
